The International Development Association (IDA) of the World Bank Group has provided a Grant to the Government of the Republic of Tajikistan to assist in financing the "Preparedness and Resilience to Disasters in Tajikistan" project.

The objective of this assignment is to meet urgent needs through more sustainable reconstruction of highways affected by floods and mudslides in May-July 2021. It is also envisaged that the proposed project will continue its efforts aimed at creating the foundation for the long-term program of the Government of RT to increase resilience to climate events and disasters, launched within the framework of the “Strengthening Critical Infrastructure against Natural Hazards” project (SCINHP), and the project proceeds from the high need for further support in general in the field of urban development, adaptation to climate change, reconstruction of critical infrastructure in the country and ensuring its resistance to natural hazards.

The Ministry of Transport of the Republic of Tajikistan (hereinafter MoT RT) with the assistance of the Project Implementation Group (hereinafter PIG) will be responsible for the implementation of Component 1 (**Building Road Resilience**) of the PREPARED project. The objectives of Component 1 include Subcomponent 1.1 Rehabilitation of roads damaged by the 2021 floods and Subcomponent 1.2. Protection and reinforcement of priority roads will aim to ensure that critical infrastructure is resilient to natural disasters.

The MoT RT intends to hire a number of specialist to assist the ProjectImplementation Group under the Ministry of Transport in the implementation of the PREPARED Project, namely:

## **1. Procurement Specialist**

- Good knowledge of Tajik and Russian languages (oral and written) and the knowledge of English language will be an advantage;
