1. The Republic of Tajikistan has received financing from the Asian Development Bank (ADB) toward the cost of **Central Asia Regional Economic Cooperation Corridors 2, 5, and 6 (Dushanbe–Kurgonteppa) Road Project – Additional Financing**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. **The Ministry of Transport of the Republic of Tajikistan** (“the Employer”) invites sealed bids from eligible Bidders for the construction and completion of Dushanbe-Dangara-Kulob Road Safety Improvements Works (km 99 to km 107) and its connecting Kangurt-Baljuvon-Khovaling road (“the Works”).
3. **Open Competitive Bidding** (national advertising) will be conducted in accordance with ADB’s [Single Stage: One-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following **key qualifications** should participate in this bidding:
  - (i) Current soundness of the Bidder’s financial position; as a minimum, the Bidder’s net worth for the last year should be positive.
  - (ii) Minimum Average Annual Construction Turnover within the last three (3) years: USD 5,469,663.00 (five million four hundred sixty nine thousand six hundred sixty three) United States Dollars).
  - (iii) The Bidder must demonstrate that its financial resources less its financial obligations for its current contract commitments meet or exceed the total requirement for the Subject Contract of not less than USD 1,025,562 (one million twenty five thousand five hundred sixty two United States Dollars).
  - (iv) Participation as a contractor, Joint Venture partner, or Subcontractor in at least one contract that has been successfully or substantially completed within the last five (5) years and that is similar to the proposed works, where the value of the Bidder’s participation is USD 2,187,865 (two million one hundred eighty seven thousand eight hundred sixty five United States Dollars).

#### Construction experience:

- Street lighting installation (285 No. poles) for the last five (5) years.
- New guardrails installation (6,600m) for the last five (5) years.
- Road sign installation (350 No.) for the last five (5) years.
- Construction of sidewalks (4,350m<sup>2</sup>, or equivalent) for the last five (5) years.
