1. The Republic of Tajikistan has received financing from the Asian Development Bank (ADB) toward the cost of **Central Asia Regional Economic Cooperation Corridors 2, 5, and 6 (Dushanbe–Kurgonteppa) Road Project – Additional Financing**, and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Ministry of Transport of the Republic of Tajikistan** (“the Purchaser”) invites sealed bids from eligible Bidders for the supply of Mobile laser scanner (for collecting passportization data), including:

1	Mobile laser scanner (Laser Imaging Detection and Ranging (LIDAR) device and related equipment and software for collecting and processing detailed inventory data for the road and right-of-way)	1

The goods shall be delivered to the Ministry of Transport of the Republic of Tajikistan within 120 days from the date of the Contract.

3. Open competitive bidding will be conducted in accordance with ADB’s [Single Stage: One-Envelope bidding procedure](#) and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:
 - Successful completion as main supplier within the last five (5) years, of at least two (2) contracts each valued at \$720,000.00 (seven hundred twenty thousand US Dollars) with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).
 - The Bidder shall demonstrate that the goods offered have: (i) been in production for at least five (5) years; (ii) been sold a minimum of two (2) units of similar type and specification over the last five (5) years, and; (iii) been in operation for a minimum of three (3) years.
 - The Bidder/Manufacturer shall demonstrate the following production/supply capacity: production/supply of at least two similar Mobile laser scanners (for collecting passportization data) per year, over the last three (3) years.
 - Current soundness of the Bidder’s financial position; as a minimum, the Bidder's net worth for the last 3 years should be positive.
 - Minimum average annual turnover of \$ 1,800,000.00 (one million eight hundred thousand US Dollars) calculated as total payments received by the Bidder for contracts completed or under execution over the last three (3) years.
 - Availability of or access to liquid assets, lines of credit, and other finances sufficient to meet cash flow requirement which is \$900,000.00 (nine hundred thousand US Dollars).

This document summarizes only a part of the requirements for information of the potential bidders. Bidders are requested to refer to the Bidding Document for the full range of criteria prior to submitting a bid. If there are any discrepancies between this Invitation for Bid and the Bidding Document, the Bidding Document shall prevail.
